#### Local Law #2-2014

A Local Law changing the date for the Board of Assessment Review to Hear Complaints regarding Assessments.

- 1. The Town of Howard hereby establishes the meeting date for the Board of Assessment Review of the Town of Howard to review and hear complaints regarding assessments on the "First Wednesday after the Fourth Tuesday in May" each year beginning in 2014. The times of the meetings for that day shall be set by the Board of Assessment Review as provided in Section 525 of the Real Property Law.
- 2. This Local Law supersedes Section 512 subsection 1 of the Real Property Tax Law as provided for in Section 512 subsection 2 of the Real Property Tax Law.
- 3. Local Law No. 1 for the year 2012 for the Town of Howard, entitled "Change in Assessment Date" (to the first Tuesday in June) is hereby repealed, revoked, and superseded.
- 4. This Local Law shall take effect immediately upon filing with the Secretary of State, the Howard Town Clerk and the State Board ORPS.
